Standard 1910.132

Personal Protective Equipment:
Protective equipment, including clothing, helmets, goggles and other guards must be used when process or environment presents a hazard of physical injury or illness.



Standard 1910.147

Lock Out-Tag Out:

Prevent the unexpected energization or start-up of machines and equipment or release of hazardous energy during service or maintenance on that equipment with the Lockout/Tagout procedure. Each worker must be provided with a lock and tag.



Standard 1910.119

Process Safety Management (PSM):

Put in place in 1992 to prevent a major unplanned release of a highly reactive, flammable, or toxic substance. OSHA lists a series of 14 elements that employers must have in place to prevent a major release.

OSHA Inspections:

Workplace safety checks are conducted by OSHA inspectors. Following a complaint or report of a workplace hazard, OSHA may conduct an inspection. These inspections are conducted by OSHA inspectors, who are trained in the use of OSHA standards and are required to conduct an inspection.
