## Important OSHA Standards Contributing to Fewer Workplace Accidents



**Standard 1910.132: Personal Protective Equipment:** Protective equipment, including clothing, helmets, goggles and other eye protection, must be used when process or environment presents hazards that could cause bodily harm.



**Standard 1910.119: Process Safety Management (PSM):** Put in place in 1992 to prevent a major unplanned release of a highly reactive, toxic, or flammable chemical or other substance, PSM has reduced the number of fatalities and injuries that result from major releases of these substances.

**Standard 1910.147: Lock Out-Tag Out:** Prohibits the unauthorized reconnection or starting of machinery or equipment until the release of hazardous energy during the servicing or maintenance of the equipment with the "lockout/tagout" procedure and 50,000 workers each year are using OSHA.



**OSHA Inspections:** OSHA inspectors conduct workplace safety and health inspections to ensure that employers are complying with OSHA standards. OSHA inspectors are trained to identify and correct safety and health hazards in the workplace. OSHA inspectors are also trained to investigate and cite violations of OSHA standards. OSHA inspectors are also trained to conduct safety and health training for employers and workers.

have a higher rate of accidents and injuries than more experienced workers. If ignorance of specific job hazards and of proper work practices is even partly to blame for this higher injury rate, then training will help to provide a solution. As an example of the trend in OSHA safety and health training requirements, the Process Safety Management of Highly Hazardous Chemicals standard, Title 29 Code of Federal Regulations Part 1910.119, contains several training requirements. This standard was promulgated under the requirements of the Clean Air Act Amendments of 1990. The Process Safety Management Standard requires the employer to evaluate or verify that employees comprehend the training given to them. This means that the training to be given must have established goals and objectives regarding what is to be accomplished. Subsequent to the training, an evaluation would be conducted to verify that the employees understood the subjects presented or acquired the desired skills or knowledge. If the established goals and objectives of the training program were not achieved as expected, the employer would revise the training program to make it more effective or conduct more frequent refresher training or some combination of these. The requirements of the Process Safety Management Standard follow the concepts embodied in the OSHA training guidelines contained in this booklet. The length and complexity of OSHA standards may make it difficult to find all the references to training. So to help employers, safety and health professionals, training directors, and others with a need to know OSHA's training-related requirements, have been excerpted and collected in this booklet. Requirements for posting information, warning signs, labels, and the like are excluded, as are most references to the qualifications of people assigned to test workplace conditions or equipment. It is usually a good idea for the employer to keep a record of all safety and health training. Records can provide evidence of the employer's good faith and compliance with OSHA standards. Documentation can also supply an answer to one of the first questions an accident investigator will ask: Was the injured employee trained to do the job? Training in the proper performance of a job is time and money well spent, and the employer might regard it as an investment rather than an expense. An effective program of safety and health training for workers can result in fewer injuries and illnesses, better morale, and lower insurance premiums among other benefits.
